

## General membership terms of the Euro Disney S.C.A. Shareholders Club

### Membership criteria

The Shareholders Club is dedicated to only individual Euro Disney S.C.A. shareholders who own 500 old Euro Disney S.C.A. shares or 5 new Euro Disney S.C.A. shares minimum.

### Administration fees

- For shareholders owning less than 2,000 old shares or 20 new shares, an administration fee of € 30 is required for a 2-year membership. These same shareholders will be exempted from the administration fee if they have been members of the Shareholders Club without interruption since the Shareholders Club creation in 1995.
- For shareholders owning 2,000 old shares or 20 new shares and more, the 2-year membership is free.

### Documents to submit

- A completed and signed membership form.
- A certificate evidencing the holding of Euro Disney S.C.A. shares. Electronic prints of online bank statements are not accepted.
- For shareholders owning less than 2,000 old shares or 20 new shares, a payment of € 30 made by cheque to the order of Euro Disney S.C.A. (Credit Cards are also accepted: Carte Bleue, American Express, Visa, Eurocard Mastercard).
- The Shareholders Club card can be renewed upon request, as long as the member justifies his/her shareholding of the required number of shares to join the Shareholders Club at that time, sends a new membership form and, if need be, the required payment.

### Shareholders Club card

- Delivery approximately 6 weeks after receiving the completed membership form and valid documents. Exceptionally a temporary certificate could be provided upon prior request addressed to the Shareholders Club during business days.
- 2-year validity as of the issue date on the membership card.
- Renewal upon written request and in accordance with the general conditions in force at the date of request.
- The membership card is personal and non-transferable - Cannot be exchanged or reimbursed. Does not give access to the Disney® Parks.
- If your card is lost or stolen, please contact the Euro Disney S.C.A. Shareholders Club by e-mail, fax or mail and send, if need be, a copy of the declaration of theft filed with the required authorities. Once the declaration has been processed, a new card will be delivered in the above-mentioned time period.
- Any change of address, name or any other necessary change must be sent as soon as possible to the Euro Disney S.C.A. Shareholders Club by mail.
- Being a member of the Shareholders Club implies the unconditional acceptance of the present general conditions of membership and the regulations of Salon Mickey, which are an integral part of the former. ### **Advantages and privileges**

- Euro Disney S.C.A. also reserves the right to terminate Shareholders Club activities for any reason and at any moment, in which case it commits to honour all reservations made up to and including this date as well as reimburse on a pro rata basis the fees already paid for 2 years, this reimbursement corresponding to the period during which the Club would no longer be in existence.
