



## Salon Mickey – Internal Regulations

### **Preamble**

Euro Disney S.C.A. exclusively offers to members of the Shareholders Club (hereafter "Members of the Shareholders Club") the opportunity to start their visit in the Disneyland® and/or the Walt Disney Studios® Parks by a light breakfast at Salon Mickey.

The present internal regulations apply to all Members of the Shareholders Club and, if the case may arise, to the persons who accompany them under the conditions defined hereunder, and sets the general rules for the smooth running of Salon Mickey.

### **Article 1 – Admission Conditions**

To be admitted to enter, settle or stay in Salon Mickey (hereafter the "Visit"), all guests must prove they are Members of the Shareholders Club to the Cast Member at the reception, by presenting a valid Shareholders Club membership card and a valid identity document, as well as an entrance ticket valid for the same day of the Visit to the Disneyland and/or the Walt Disney Studios Parks.

Exceptionally, Members of the Shareholders Club may be accompanied by a person of their choice (hereafter the "Guests") under the following conditions:

(i) either four (4) Guests maximum per Visit in so far as the Guests can prove they are the spouse or partner, children or parents;

**or**

(ii) three (3) Guests maximum per Visit in so far as these persons are other than the ones mentioned above;

it being specified that each Guest must present to the Cast Member at the reception an entrance ticket valid for the same day at the Disneyland and/or the Walt Disney Studios Parks.

In any case, the Guests will only be allowed to enter, settle and stay in Salon Mickey in so far as they accompany one or several Members of the Shareholders Club.

Attendance at Salon Mickey by Members of the Shareholders Club, whether accompanied or not by Guests, is limited to five (5) Visits per month, it being understood that one unique visit is authorized per day during opening hours. In case of non-compliance with this measure, each repeated visit to Salon Mickey during the same day shall be deducted from the number of authorized Visits in the concerned month.

### **Article 2 – Opening and closing hours**

Salon Mickey is open all year long, only from 9:00 a.m. to noon, and is subject to limited hosting capacity. Euro Disney S.C.A. has the right to close Salon Mickey temporarily or definitely for any reason, at any time.

### **Article 3 – Hosting Capacity**

For safety reasons, the hosting capacity of Salon Mickey is limited to thirty (30) persons during opening hours. Consequently, beyond that threshold, Members of the Shareholders Club and, if the case may arise, their Guests will not be admitted to enter, settle or stay in Salon Mickey.

### **Article 4 – Light breakfast**

A light breakfast will be served or made available to Members of the Shareholders Club and, if the case may arise, to their Guests if the supply is available. This snack must be eaten on site and all breakfast rolls and buns, beverages, sweets or other food should not be taken away.

#### **Article 5 – Respect of the property and of people**

- (i) For the comfort and safety of all, pushchairs must be left at the reception of Salon Mickey.
- (ii) Salon Mickey should be kept in the state in which Members of the Shareholders Club and, if the case may arise, their Guests will have found it when they entered it. Members of the Shareholders Club and, if the case may arise, their Guests are requested to abstain from any acts that could affect the cleanliness, hygiene, safety or respect of the property. It is, in particular, strictly forbidden to throw any papers, trash or other refuse on the floor or on the furniture. Any damage caused to the furniture or the property will be the author's total responsibility.
- (iii) In any circumstances, Members of the Shareholders Club and, if the case may arise, their Guests should not behave in any way that could disturb or disrupt the Visit of other Members of the Shareholders Club, or if the case may arise, their Guests.
- (iv) Children that accompany Members of the Shareholders Club and, if the case may arise, their Guests must always be under their watch.
- (v) Members of the Shareholders Club and, if the case may arise, their Guests are invited to take their usual precautions regarding the surveillance of their bags, clothes or other personal effects.

#### **Article 6 – Direct access to the Disneyland® Park**

Members of the Shareholders Club and, if the case may arise, their Guests may access the Disneyland Park through Salon Mickey only upon direct request to the Cast Member in charge of the reception and only once their entrance tickets have been duly validated.

#### **Article 7 – Posting**

The present internal regulations are posted in Salon Mickey and are handed to the Members of the Shareholders Club upon simple request addressed to the Shareholders Club.

#### **Article 8 – Non-respect of the internal regulations**

In case of non-respect of the provisions of the present internal regulations, the Cast Member in charge of the reception will remind Members of the Shareholders Club and, if the case may arise, their Guests of their obligation to comply with the present internal regulations. The Cast Member may, according to the case, refuse their entrance to Salon Mickey, instruct them, orally, to immediately cease their misbehaviour or their disruption, and in case of serious troubles, call the Security Department of Disneyland Resort® Paris.

In case of serious and /or repeated breach of the internal regulations, the Cast Member in charge of the reception will inform the persons in charge of the Shareholders Relations at the Shareholders Club. Members of the Shareholders Club responsible will face sanctions that can go up to the exclusion from the Shareholders Club.

#### **Article 9 – Modifications**

Euro Disney S.C.A. may modify the provisions of these internal regulations without any previous notice. Any tolerance that could be, if the case may arise, authorised exceptionally, must in no case whatsoever be considered as a change of any sort of the present internal regulations.
